TERMS AND CONDITIONS

The terms, "**GreatCycling**", "**we**" and "**our**" refer to 375645 Ontario Ltd., an Ontario corporation, which carries on business as Victor Travel, Victours and GreatCycling, as a tour operator registered under the Travel Industry Act of Ontario (registration nos. 18923547/1243371), which offers and operates all the trips listed herein. All trips are offered subject to GreatCycling standard terms and conditions, which are found here. Please review the terms and conditions carefully prior to completing your reservation. These terms and conditions are set out below to draw your attention to the fact that our obligations to you are limited.

Prices, Reservations and Payment

Our prices are in Canadian and U.S. dollars. There are no charges other than as shown on our website tour pages. Our tours can be taken during any month where we offer tours and there are no additional charges for summer months when there is generally more demand.

We do charge a single supplement to individual travellers who wish to ensure that they have private rooms throughout a trip. We charge for bike rentals and for some transfers. If such additional charges apply to the tour chosen by you they will be reflected in your invoice.

To reserve your trip, we require a deposit of US or CDN \$1,000 per person. The balance of your payment is due 90 days prior to departure. If reserving your trip within 90 days of departure, full payment is required. To complete your reservation, you must complete, sign and return our Application Form and an Acknowledgment of Risk, Release and Indemnity within 14 days of the receipt of your invoice.

Prices for our custom trips are due and payable in full within 14 days of delivery of invoice.

Cancelling

If you must cancel your reservation, the fees for doing so are as follows:

DAYS PRIOR TO DEPARTURE CANCELLATION FEE – SELF GUIDED TOUR

96-270	Refund of \$500.
61-95	25% of trip price
0-0	100% of trip price

DAYS PRIOR TO DEPARTURE CANCELLATION FEE – CUSTOM TOUR

91-270	Refund of 50% of trip price.
90-0	100% of trip price

Cancellation Insurance

We recommend you purchase cancellation insurance to protect yourself from unexpected circumstances that may cause you to cancel your trip. We recommend cancellation and out of province/country medical insurance. You will be required to confirm in writing your decision to decline travel protection, or if we do not receive
